- 1. To apply for any of the course, fill up the enrollment form available at our offices in your own hand writing.
- 2. The available seats are limited and will be filled in first come first serve basis.
- 3. Incomplete from will be rejected. It is compulsory to attach photocopy of mark sheets and two recent passport size photographs with the enrollment form.
- 4. It is compulsory to provide correct details of Parents. The result of tests or any other information by the institute will be sent via SMS.
- 5. Any change of address or telephone number should be notified in writing to the office within 10 days.
- 6. Students enrolled have to provide photocopy of Admit Card of Exam, as soon as they receive their admit cards from the examining body. The Kap Academy reserves the right to use the photograph for publicity in case the student secures position/success in any of these examinations.
- 7. Mobile phone is not allowed in the class. If at all student carries mobile phone in the class, then it should be kept switched off. The Institute is not responsible for any loss/theft of any personal belongings in the Institute.
- 8. A student, who is late by more than 10 minutes for classes/tests, will not be allowed to enter the classroom.
- 9. In case of lost/misplaced study material, study can obtain duplicate set of book(s) against payment of respective fees.
- 10. In case of any mishap because of reasons beyond control or any natural calamity of any type (earthquake, floods, fire, electric short circuit etc) occurs in the premises of Kap Academy, the institute shall not be responsible in any manner whatsoever.
